Addendum Renewals

Addendum F-06-1.

The committee shall have the right to make minor grammar and spacing corrections to the Services and Activities Fee Guidelines.

Addendum F-06-2.

The committee shall have the right to discuss, deliberate, and/or vote on proposals which address Services and Activities Fee Committee operational funds.

Addendum F-06-3

Addendum in accordance with SAFC Guidelines and in particular, Section II-C a spokesperson for the committee shall be appointed by the committee to serve as a liaison between the committee and the chancellor, members of the media, and other public entities. The term of the spokesperson for the committee will be the term of the membership of the committee and/or the term of the academic calendar, whichever is shorter. The spokesperson must volunteer for the position and the appointment must be approved by the majority of the committee. This position will be by volunteer and receive no extra compensation in any form. The spokesperson represents the opinions of the SAFC which may not necessarily reflect the opinions of the university as a whole.

Addendum F-06-4

Addendum which allows the committee to hire a part time assistant to aid in duties such as taking minutes, filing papers, retrieving copies, and other duties needed by the committee in order to operate effectively and efficiently. This position shall be paid a quarterly stipend based upon a range of five (5) to fifteen (15) hours per week. The appointment of the position to an individual shall be approved by the committee. The assistant will report to the Chair of the Committee.

Addendum F-06-5 – As Amended

This addendum is to strike the language of “ or hold a paid/stipend position within Student Affairs” from the Services and Activities Fee Committee (S.A.F.C.) Guidelines Section II – Committee on Services and Activities Fees, Article A – Membership, Number 2.

Additionally this addendum is to insert “, department ,” following the word “group” in the Services and Activities Fee Committee (S.A.F.C.) Guidelines Section II – Committee of Services and Activities Fees, Article C – Responsibilities of the Voting Members, Number 8.

Addendum W-07-1

This addendum is to add a Number 9 to Section II – Committee on Services and Activities Fees, Article C – Responsibilities of Voting Members to read as follows:

9. The Committee chair shall be selected by its membership

Addendum W-07-2

This addendum is to move Section II – Committee on Services and Activities Fees, Article E. – Committee Meetings, and Section II, Article-E.a. to Section II - Committee on Services and Activities Fees, Article D. - Responsibilities of Ex-Officio and the Compliance Officer as Number 7. with the following insertions and additions.

E. The Compliance Officer shall serve as interim chair of the Committee until a chair is elected by its membership. The compliance officer if elected by the Committee shall serve as chair of the Committee.

- a. The Compliance Officer will be a neutral, non-voting member who maintains compliance with the relevant laws of the state of Washington, University policies, parliamentary procedures, as well as the guidelines laid out in this document.

Addendum W-07-3

This addendum is to insert the words 12:00pm (noon) after the word “than” and before the word “the” in, Section III – Budgeting, Article B. – Annual Budgeting Process, Number 4. and add the following sentence to the end of Number 4., “Late submissions will not be considered during the annual budgeting process.” The new language would read as follows:

4. Annual budget request forms and all supporting documentation must be returned to the Committee not later than 12:00pm (noon) the second Monday in March. Late submissions will not be considered during the annual budgeting process.

Addendum W-07-4

This addendum is to strike the words, “end of business” and replace it with the words, “12:00pm (noon) in Section III – Budgeting, Article C. – Annual Budget Allocation Appeals and Disputes, 1. – Budget Allocation Appeal, letter a. The new language would read as follows:

- a. If a proposer or any other student objects to a budget allocation of Services and Activities Fee funds that has been made by the Committee, a written appeal must be submitted to the Committee chair by 12:00p.m. (noon) on the second Friday in April. An extension of the deadline shall not be granted.

Addendum W-07-5

This addendum would insert a space in between the words “Tacoma” and “will” in Section IV. – Expenditure Reviews, Article B. – Stipulations and Addendums, Number 2.

Addendum Sp-07-1

This addendum is to amend section II-A-4 – Striking the words “second Monday in May” and replacing with “third Friday in May.” The section shall now read:

4. All of the voting members shall be recommended by the third Friday in May.
